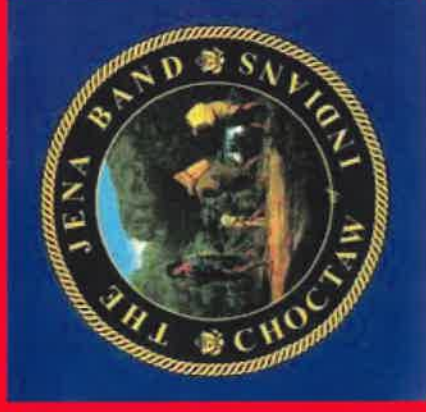


The JBCI Social Services' "Victim Assistance Program" to help tribal members who are victims of crime.

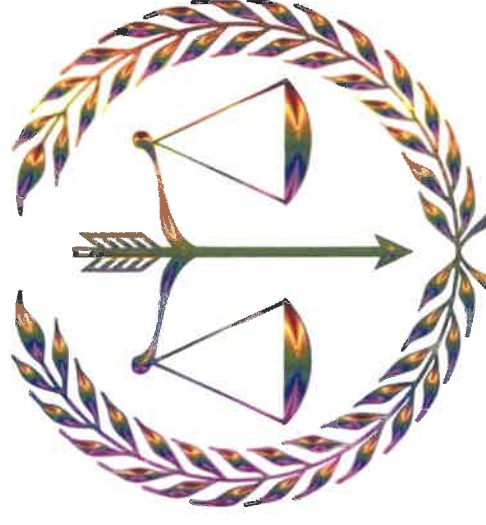
